Joe Kantz shared his thoughts on Timberhaven bringing their business to Snyder County, "As a former National Sales Manager for County Log Cabins, I know how impactful a good quality log home company can be in a family's life. Timberhaven will establish its new home in the pre-existing 27,000 sq. ft building (previously Penn Truss Systems) located at 1081 Salem Church Road. A 16,800 sq. ft. steel frame addition is currently under construction and many building renovations are also underway. With this move to the 22-acre property, Timberhaven Log & Timber Homes will bring 16 new jobs to the county and plans to manufacturer dozens of custom log and timber homes per year.

Timberhaven's relocation process will include 10-13 tractor trailer truck loads of manufacturing equipment plus 45 truckloads of logs, timbers and other related building materials. It is expected the relocation of the aforementioned materials will take 4-6 weeks to complete. The company is expecting to open its doors in Snyder County sometime in January 2016.
